Definition Description:

The goal of this definition is to detect emergency department (ED) visits related to all-terrain vehicle (ATV) (trafficrelated or non-traffic-related) accident injuries. With this information public health agencies can monitor the burden and trends of ED visits related to these types of accidents, understand the types of injuries observed, and identify possible places/methods for prevention.

<u>Use-Cases for Definition:</u> Case-finding: Not Intended as Use Case Trend monitoring: Primary Early outbreak detection: Not Intended as Use Case Emergent Condition: Secondary

<u>Justification</u>: There are ICD-10 and SNOMED codes for these type of injuries, but the specific appropriate diagnosis codes are not always assigned or reported. By also querying the Chief Complaint for text terms, we can detect additional visits of interest in order to attain a fuller understanding of the burden of ATV accidents and the associated types of injuries.

Data Source During Development: Emergency Department visits

<u>Validation Methods</u>: Each of the five participating jurisdictions (Alaska, Colorado, Nebraska, Snohomish County (Washington), and Wisconsin) manually reviewed the data details of emergency department visits returned by the initial version of the query. Each jurisdiction classified visits as true or false positives, and calculated positive predictive values. False positives were visits that were not for an ATV accident or visits where the person was injured while doing maintenance or some other activity on a parked ATV (and there was no indication that the ATV was moving or had been moving). False positives were reviewed to identify patterns of why they were included, and the query was improved, where possible, to remove false positives. Additionally, the query syntax was adjusted to also include "side by side" vehicles. Four of the five jurisdictions manually reviewed the results of the updated, final query and calculated positive predictive values for the final version of the query.

<u>Validation Results</u>: For the final version of this query, the positive predictive values were 91% for Nebraska, 94% for Colorado, 95% for Alaska, and 96% for Wisconsin.

<u>Limitations</u>: Injuries suffered while lifting, moving, or performing maintenance on an ATV can be difficult to negate, and therefore might be included. By design, the query includes diagnosis codes for 'other' type of ATV which might include vehicles that were not intended to be included. The authors decided to include syntax to

search for "side by side" type ATVs which, despite efforts to negate specific terms (e.g., "living in"), can result in some unexpected false positives not related to "side by side" ATVs. The query does not limit visit to certain types of symptoms or reasons for visit. As a result, the query might return visits where an ATV was mentioned but the reason for visit was not related to an ATV accident (e.g., getting something in their eye or getting hit in the face with an object while riding an ATV).

Definition Fields and Structure:

The Chief Complaint Discharge Diagnosis Parsed Free Text field (also applied to Chief Complaint History) is used to query discharge diagnosis codes and free text with exclusions (as necessary), to develop the syndrome definition.

Visits are included if they have either of the following:

- One or more of the diagnosis codes listed in Table 1.
- Text terms or abbreviations that refer to all-terrain vehicles (ATV), utility vehicles (UTV), four-wheelers, three-wheelers, or side-by-side utility vehicles.

Visits are excluded if they have Chief Complaint or Chief Complaint History text terms that:

- Refer to vehicles that are not "ATVs" (i.e., snowmobiles, buggies, dirt bikes, motorcycles, or golf carts).
- Refer to "side by side" that has a different meaning than the type of utility vehicle.
- Refer to the occurrence happening in the distant past.
- Indicate the person was working on the vehicle.
- Indicate the person was seeking a return to work notice.

Plain Language Syntax Description

The diagnosis codes are searched for ICD-10 codes related to injuries while being a passenger, driver, people outside of vehicle, or boarding or alighting a 3- or 4- wheeled all-terrain vehicle (ATV) or utility vehicle (UTV) – in traffic and non-traffic accidents. The diagnosis codes are searched for SNOMED codes related to off-road land motor vehicles.

Chief Complaint and Chief Complaint History are searched for phrases that indicate the visit was related to an ATV, UTV, side by side, 4 wheeler, or 3 wheeler accident.

Certain phrases like "ATV helmet" or indications that the accident occurred in the distant past or indications the visit was for a return to work notice are excluded. Terms that indicate the accident involved a non-ATV/UTV vehicle (i.e., golf cart, dirt bike, buggy, motor cycle, snowmobile) are excluded.
