Definition Description: The goal of this definition is to detect emergency department (ED) visits related to small recreational off-road motor vehicles, including all-terrain vehicles (ATVs), utility task vehicles (UTVs), dune buggies, golf carts, go carts, dirt bikes, motor/cross bikes, snowmobiles, or snow bikes. This includes traffic-related and non-traffic-related accident injuries. With this information, public health agencies can monitor the burden and trends of ED visits related to these types of accidents, understand the types of injuries that result, and identify possible places/methods for prevention.

Case-finding: Not Intended as Use Case

Trend monitoring: Primary

Early outbreak detection: Not Intended as Use Case

Emergent Condition: Secondary

Justification: There are ICD-10 codes for these type of injuries, but the specific appropriate codes are not always assigned and reported. By querying the chief complaint, triage notes, and clinical impression we can get a better understanding of the burden of small recreational off-road motor vehicle accidents and the resulting types of injuries.

Data Source During Development: Emergency Department visits

Validation Methods: Five jurisdictions (North Dakota, Washington, Minnesota, North Carolina, and Wisconsin) manually reviewed the data details of ED visits returned by the initial version of the query. Each jurisdiction classified visits as true or false positives and calculated positive predictive values. False positives were visits where the accident occurred in the distant past and was not the reason for the current visit, or the person was lifting or performing maintenance on the vehicle itself when the person was injured. False positives were reviewed to identify patterns of why they were included, and the query was improved, where possible, to remove false positives.

The jurisdictions manually reviewed the results of the updated, final query and calculated positive predictive values for the final version of the query.

Validation Results: For the final version of this query, the positive predictive values were 95% for North Dakota, 92% for Washington, 80% for Minnesota, and 95% for Wisconsin.

Limitations: Injuries suffered while lifting, moving, or performing maintenance on a vehicle can be difficult to negate, and therefore might be included. The authors decided to include syntax to search for “side by side” type ATVs which, despite efforts to negate specific terms (e.g., “living in”), can result in some unexpected false positives not related to “side by side” ATVs. The query does not limit visits to certain types of symptoms or reasons for visit. As a result, the query might return visits where a small recreational off-road motor vehicle was mentioned but the reason for visit was not related to a small recreational off-road motor vehicle accident (e.g., person had a heart attack and was then transported in an ATV). For jurisdictions with facilities that report Triage Notes or Clinical Impression, this version of the query will detect additional true positives but will also return more false positives than Small rec off-road motor vehicle v1.

Definition Fields and Structure:

The Chief Complaint Discharge Diagnosis Parsed Free Text field (also applied to Chief Complaint History, Triage Notes, and Clinical Impression) is used to query discharge diagnosis codes and free text with exclusions (as necessary), to develop the syndrome definition.

Visits are included if they have either of the following:

- One or more of the diagnosis codes listed in Table 1.
- Text terms or abbreviations that refer to small recreational off-road motor vehicles (all-terrain vehicles (ATVs), utility task vehicles (UTVs), dune buggies, golf carts, go carts, dirt bike, motor/cross bike, snowmobiles, or snow bikes).

Visits are excluded if they have Chief Complaint, Chief Complaint History, Triage Notes, or Clinical Impression text terms that:

- Refer to the occurrence happening in the distant past.
- Indicate the person was performing maintenance on the vehicle or loading or lifting the vehicle.
- Indicate the visit was for a follow up or medication refill.
- Indicate the visit was related to skiing or ski patrol.

Plain Language Syntax Description

The diagnosis codes are searched for ICD-10 codes related to injuries while being a passenger, driver, people outside of vehicle, or boarding or alighting a small recreational off-road motor in traffic and non-traffic accidents. The diagnosis codes are searched for SNOMED codes related to these vehicles.

Chief Complaint, Chief Complaint History, Triage Notes, and Clinical Impression are searched for phrases that indicate the visit was related to a small recreational off-road motor vehicle.

Certain phrases indicating the visit was related to lifting, loading, or performing maintenance on the vehicle, or that the visit was a recheck or medication refill visit, or that the accident occurred in the distant past are excluded. In addition, terms that indicate the visit was related to skiing or ski patrol are excluded.
